Agenda Items:

1. Sgt Positions PC:

Sgt positions are not going away.

2. Open Lt Positions

PC: I know of one position. Unsure if more will be available. When more positions come, I will send an email at that time.

3. Supervisor Requirement for Upload/Download Procedures

PC: We will upload/download due to requirement of Federal Supervisors overseeing guards. The reason is due to policy.

VS: Could we please have a copy of the policy?

4. Mid-watch SD
